Overall aspects

- The guideline document was developed by the ICPerMed and ERA PerMed Preparatory Group
- It aims to provide information about the processes and developments in relation to the upcoming European Partnership for Personalised Medicine (EP PerMed) under Horizon Europe
- It intends to provide support for representatives of national and regional authorities, ministries, funders and policy makers and the personalised medicine stakeholder community to become involved with EP PerMed
- The path towards EP PerMed is work in process. Thus, this guideline is a dynamic document that will be updated when new information or developments become available.
- The guideline can be accessed via the ICPerMed and ERA PerMed web pages

Why an EP Permed guideline?

- When the EP PerMed Concept Paper was released it raised a lot of questions about the "What", the "When" and the "How"
- The ICPerMed/ERA PerMed's approach to the "What" has been described in the Concept Paper.
- The "When" is determined by the Horizon Europe timeline with expected launch of EP PerMed in 2023
- Regarding the "How" it was clear that there was a lot of uncertainty and as a result these guidelines were developed
- It is intended with these guidelines to foster participation of interested organisations in the EP PerMed and help organising the baselines for preparations on the regional and national level.

Guideline Information Sheets

A series of information sheets have been developed to provide more detailed information on key aspects:

- Definition of PM and the value for healthcare systems (summary of the EP PerMed draft concept document)
- Description of the target groups/stakeholders to be involved in EP PerMed
- Setting-up national Hubs
- Regional involvement
- Joint Funding and funding opportunities in EP PerMed (national and regional perspective)
- Involvement of industry
- International perspectives

Key aspects of the guidelines

Promoting EP PerMed within countries and regions

- The national/regional commitments are absolutely vital to make the EP PerMed come alive.
- Thus, it is highly recommended to foster constructive interactions between the regional and national key players as soon as possible
- This should be a push-pull process:
 - The pull: the decision-making bodies for each country/region should ensure that all relevant key players are consulted
 - The push: ICPerMed/ERA PerMed are launching dedicated communications promoting the EP PerMed; Regions will be additionally motivated through dedicated communications of CSAs that are focusing on the regional dimension (SAPHIRe and Regions4PerMed)

Key aspects of the guidelines

Member States consultations

- The European Partnerships are developed in a co-creation process organised by the EC together with the Member States.
- It is important that the individual Member States representatives bring a collective input from all relevant stakeholders of the particular Member State/region
- Total committed budget from Member States must be of a size "that can make a difference" in order for EP PerMed to come alive
- Other types of commitments are also important, e.g. in kind contributions, access to infrastructures and facilities, etc.
